# Freedom of Information request: Right to know request

Thank you for your request concerning how many jobs went to internal staff rather than external candidates over the past year. Your original request was received on 13 December 2023. We sought clarification on 14 December 2023 and clarification was received from you on 19 December 2023, and we have considered it under the Freedom of Information Act 2000 ('the FOI Act').

### Background

Ofcom believes that our colleagues are fundamental to our success. As clarification was received from you on 19 December 2023 we have based the last year on 19 December 2022 to 19 December 2023. Between this period, we can confirm that 378 roles were filled. Of these, 141 were filled by internal candidates and 237 were filled by external candidates.

## Information Requests

If you are unhappy with the response you have received in relation to your request for information and/or consider that your request was refused without a reason valid under the law, you may ask for an internal review. If you ask us for an internal review of our decision, it will be subject to an independent review within Ofcom.

The following outcomes are possible:

- the original decision is upheld; or
- the original decision is reversed or modified.

#### Timing

If you wish to exercise your right to an internal review **you should contact us within two months of the date of this letter**. There is no statutory deadline for responding to internal reviews and it will depend upon the complexity of the case. However, we aim to conclude all such reviews within 20 working days, and up to 40 working days in exceptional cases. We will keep you informed of the progress of any such review. If you are not content with the outcome of the internal review, you have the right to apply directly to the Information Commissioner for a decision.
