Freedom of Information request: Right to know request

Thank you for your request for information concerning the Online Safety Act documents showing tracked changes.

We received this request on 17 December 2024. We have considered your request under the Freedom of Information Act 2000 ("the FOI Act").

including (but not limited to) the Risk Assessment Guidance and Risk Profiles.

Ofcom must have, internally, documents with tracked changes showing the differences between the documents published yesterday, and their draft versions published for consultation previously.

In the past Ofcom (perhaps other departments) has been very good about providing documents online that were marked up to show the changes between the consultation drafts and the final guidance, but inexplicably it seems Ofcom has NOT done so on this occasion, despite there being so many documents that people have to wade through.

Accordingly, this is a request for copies (PDF or Word is fine) of Ofcom's documents with tracked changes that show the differences between the published consultation drafts and the versions published yesterday, for every document linked to from the webpage above where a previous draft was published by Ofcom.

Our response

We do not hold comprehensive internal versions of our regulatory products that track each change made since the November 2023 Illegal Harms Consultation.

Request an internal review

If you are unhappy with the response you have received to your request for information, or think that your request was refused without a reason valid under the law, you may ask for an internal review. If you do, it will be subject to an independent review within Ofcom. We will either uphold the original decision, or reverse or modify it.

If you would like to ask us to carry out an internal review, you should get in touch within two months of the date of this letter. There is no statutory deadline for us to complete our internal review, and the time it takes will depend on the complexity of the request. But we will try to complete the review within 20 working days (or no more than 40 working days in exceptional cases) and keep you informed of our progress.
