Whilst competition is nor- mally of benefit to users the impact on the letter service for individuals in a shrinking market has been the opposite. Competition has had little, if any, benefit to individual's outgoing mail but has seen excessive price rises. Since the turn of the century RPI infla- tion, according to government statistics, it has increased by approximately 90% whereas first class post costs have gone up from 27p to the current 85p, an increase of approximately 215%-, and second-class rates (19p to 66p) by nearly 250%. While ob- viously not the only reason for volume de- cline it represents a major factor to many in- dividuals. Such excessive increases in postal rates make the service unsustainable. This significantly contradicts the affordability requirements in your consultation ("Ensuring the affordability of services"). Perhaps those competitors in the bulk letter aspect of the service should make a greater contribution to the UPS to benefit those users who have not seen any appreciable benefit so far and to support the overall sustainability of the service to all users.
