## Question

Question 1: Functioning of the net neutrality framework

## Your response

We have recently conducted research funded by BT exploring a legal and policy perspectives of the UK's net neutrality rules and how successful they have been in achieving their goals.

We draw on this research in this consultation response. The views we express here and in the report are our own and do not represent the views of BT.

Overall, we found that there is general compliance with net neutrality rules, especially the prohibition on blocking legal content, application, services and devices.

However, it would be good to clarify further situations in which zero rating and use of content delivery networks may infringe net neutrality rules, especially in light of the recent Court of Justice of the EU (CJEU) cases on zero-rating.

We also note that net neutrality rules have not prevented the growth and further consolidation of digital intermediaries in over-the-top services. We note the parallel policy initiatives in the EU (Digital Markets Act) and UK (A new pro-competition regime for digital markets Government consultation) and urge any reform to net neutrality rules to cohere with these other initiatives.

We ponder whether there should be a reconsideration of net neutrality rules and in particular the categorical prohibition on commercial traffic management practices. We still consider that blocking and actively slowing traffic down should be prohibited but are there can be permissible circumstances in which delivering content more

	quickly and/or for free could be legalised, subject to general competition rules and special monitoring, transparency and accountability mechanisms while ensuring citizen and consumer interests and media pluralism goals are also met. We would encourage Ofcom to consider this possibility for future reform.
