Reverting to A2 Project work for 2022/2023

**Consumer information on gigabit-capable / ultrafast broadband**: common terminology has been promised for many years , a final decision on the meaning of words would be very welcome along with a publicity campaign to ensure the general public has knowledge of what they should receive when such terms are used

**Mobile strategy:** as with the first point a common understanding of the terminology would be of great help in assessing the value offered from a provider, terms such as 5G should be clearly defined

Award spectrum bands as they are cleared and released: Non-public networks offer great advantages to UK PLC and should be prioritised over public networks who should be encouraged to ensure efficient use(and coverage) of their existing allocation's

**Database approach to spectrum management:** an extremely practical and comprehensive method of allocation in use since the early 1990s and expanse of this would speed up allocation's, providing there is a human option for allocation's which may not fully fit within the database configuration

**2G/3G switch off**: in some arears these are the only options please ensure at least the same coverage/signal strength as existing system

**Broadband universal service:** often promised but not achieved a combination of fibre and nonpublic radio systems should be encouraged

**Review of USO telephony services:** call boxes in many arears such as the lake district and Scotland are still the only way of calling for help and must be retained as the public has re-found the joys of wild spaces

## Improving consumer information on mobile coverage and performance. &

**Mobile coverage:** in both cases real world data is the key as opposed to the optimistic maps currently provided

**Supporting vulnerable customers:** this should also include identifying the needs of those with disabilities and ensuring their needs are addressed

**Mobile spectrum demand:** the review should take into account if current allocation's are effectively being used and their coverages is maximised

**International engagement**: with the information provided in the draft work plan some 13 references are made to content production arears ,PMSE is the pen and pencil of the content production industry and the UK is a major player in this area and whilst appreciating the current Ofcom position on PMSE for WRC 23 a much greater proactive approach is required to ensure the continued access to the 470-694MHz tuning range on a Region 1 basis in both the near and far future

**Licence variations;** as part of the review the coverage conditions should be considered and possible population coverage should be changed to geographical coverage,

**Commonwealth Games, Birmingham, 2022:** with the excellent results at the 2012 Olympics we look forward to a similar result

**Public service broadcasting programme:** please ensure that the content production requirements are fully considered

**Making Sense of Media:** information on the use of PMSE devices should be included in the *improvement of skills, knowledge and understanding*
