

Direction under section 106(3) of the Communications Act 2003 applying the electronic communications code

Background

1. LF HOLDCO 2 LTD, whose registered company number is 15474345, has applied to Ofcom for a direction applying the Code to it.
2. The date on which Ofcom received a completed application that meets the statutory requirements with respect to the content of an application for a direction applying the Code and the manner in which such an application is to be made was 18 July 2024.
3. By virtue of regulation 3 of the Electronic Communications and Wireless Telegraphy Regulations 2011 (SI 2011 No. 1210), except in cases of expropriation, Ofcom must make its decision within 6 months of receiving the completed application.
4. Prior to giving a decision under section 106(3) of the Act to apply the Code to LF HOLDCO 2 LTD, Ofcom must publish a notification of its proposal to give the direction and consider any representations about that proposal that are made to Ofcom within the period specified in the notification.
5. On 5 August 2024, Ofcom published a notification in accordance with section 107(6) of the Act of its proposal to give a direction applying the Code to LF HOLDCO 2 LTD. That notification invited representations to Ofcom by no later than 5 pm on 5 September 2024.
6. Ofcom received one response objecting to the proposal set out in consultation. The response raised concerns about the nature of the Applicant as a recently formed company. Ofcom did not consider that the object raised any issues that were material to its consideration of the application and remained satisfied that the Applicant has provided it with information which demonstrates that it understands the obligations associated with the use of Code powers.
7. For the reasons set out in the explanatory statement accompanying Ofcom's consultation, Ofcom has had regard, in particular, to each of the matters set out in section 107(4) of the Act.

Furthermore, Ofcom has considered and acted in accordance with its general duties in section 3 of the Act and the six requirements in section 4 of the Act.

Decision

8. Ofcom hereby directs, in accordance with section 106 of the Act, as follows—
 - (a) the Code shall apply to LF HOLDCO 2 LTD (whose registered company number is 15474345) for the purposes of the provision by it of an electronic communications network; and
 - (b) that application of the Code shall have effect throughout the United Kingdom.
9. This Direction shall take effect on the day it is published.

Interpretation

10. In this Direction—

- (a) “**Act**” means the Communications Act 2003;
- (b) “**Code**” means the electronic communications code set out in Schedule 3A to the Communications Act 2003;
- (c) “**Ofcom**” means the Office of Communications.

11. For the purpose of interpreting this Direction—

- (a) headings and titles shall be disregarded;
- (b) the Interpretation Act 1978 shall apply as if this Notification were an Act of Parliament.
