Bectu has always championed for increased commissioning from public service broadcasters that supports the economic development of the UK's nations and regions and allows for representation in British programming from all four corners of the UK. Investment in cultural film and TV production outside of England will allow for programming and storytelling that reflects the diverse communities across Britain and improve the way that different cultures and traditions in communities are represented to viewers.
Question 2: Do you agree with our Welsh language impact assessment?	We agree that Ofcom's proposals will not have an impact on opportunities for persons to use the Welsh language and will not treat the Welsh language less favourably than the English language.
Question 3: Do you agree with our proposals that: a) until 31 December 2029, in each calendar year at least 9% of the hours of programmes made in the UK for viewing on the Channel 4 service must be produced outside England, and at least 9% of the expenditure on programmes made in the UK for viewing on the service must be allocated to the production of programmes outside England and referable to programme production at production centres in	a) Bectu does not support Ofcom's proposal that until 31 st December 2029 at least 9% of the hours of programmes must be produced outside England, and instead proposes an acceleration to 2027 of Channel 4's Outside of England quota of 12%. The addition of both annual progress reports and annual strategy reports alongside this would enable Ofcom to hold Channel 4 accountable to such requirements, and for a clear commissioning strategy in Scotland, Wales and Northern Ireland, ensuring transparency in broadcasting.
b) with effect from 1 January 2030, in each calendar year at least 12% of the hours of programmes made in the UK for viewing on the Channel 4 service must be produced outside England, and at least 12% of the expenditure on programmes made in the UK for viewing on the service must be allocated to the production of programmes outside	b) Bectu also believes that Channel 4 should use the quota of 16%+ of Outside of England as a 'stretch goal' for the period 2027-2034, and for there to be a decision on the pace of progress towards the 16% goal, in 2027. Furthermore, we want to see individual production quota targets for Channel 4's commissioning in Wales, Northern Ireland and Scotland, from 2027 at the latest. This is to ensure that equal opportunities exist for

England and referable to programme production at production centres in Scotland, Wales and Northern Ireland?	creatives in each nation, and quotas should be pro rata to each nation's share of the overall UK population, to guarantee equal investment and foster creativity in all four corners of the UK. Additionally, Channel 4's existing voluntary 50% Outside of London quota should become a condition of its renewed licence, to further develop production outside the capital, and ensure that content is not overwhelmingly London centric.
Question 4: Do you agree with our proposed guidance for C4C on how it should report on its MoE production in its SMCP?	We agree with the proposed guidance for C4C to publish more information about its approach to delivering production for the nations and regions, including the impact this may have on producers and the audiences it needs to attract. In particular, we support the proposal to ask C4C to set out how its approach to commissioning outside of England supports TV production in the nations, its strategy for commissioning for each individual nation, and its plan to engage with stakeholders in the next year, as well as details of how it delivered such requirements in the previous year.
