Finestripe Productions is an award winning fully independent production company owned and run by women. We set up in 2009 and have made programmes for major broadcasters both here and in the US. Bank of Dave was made by us for Channel 4 in 2012 and it has now been made into two feature films for Netflix starring Rory Kinnear. Most recently we have produced The Mysterious Mr Lagerfeld was a Bafta winning feature length documentary made for the BBC last year. We also made Boris Becker: The Rise and Fall for ITV and two series of Sophie Grigson: Slice of Italy for Discovery. Probably the most powerful documentaries that we have made are the ones presented by Davina McCall on the menopause. We changed the national conversation and the law in England. From 2027 at the latest, individual production quota targets for C4's commissioning in Wales, Northern Ireland and Scotland. This would ensure opportunities exist for the talented people based in each home nation annually. These quotas should be pro rata to each nation's share of overall UK population. C4's existing, voluntary, 50% Outside of London quota to become a condition of its renewed licence.
