ACE Response	As the Advisory Committee for England, we advise Ofcom about the interests and opinions of persons living in England in relation to communications and postal matters. As a committee, we are inde- pendent and our views do not represent the views of Ofcom. Our members have experience in broad- casting, independent production, mobile and fixed telecommunications and education in the media field. We are responding to Ofcom's consultation on Channel 4's Made out of England (MoE) quota from the perspective of television audiences in England and those stakeholders employed by Channel 4 and its key suppliers living in England.
	As a Committee, we meet Channel 4 on an annual basis. We hear how they have served the interests of those living in England, and what aims and am- bitions they have for the future. We also meet, from time to time, with representatives of inde- pendent production in England and groups repre- senting viewers and consumers of Channel 4's content.
	We appreciate that Ofcom is seeking to strike a balance between allowing Channel 4 Corporation greater flexibility in the future to develop its con- tent and distribution strategy in support of its digi- tal transformation, while continuing to secure its investment in distinctive UK content and the deliv- ery of the core elements of its linear output on Channel 4.
	We note that Ofcom consulted in December 2023 on its proposals for the renewal of Channel 4's li- cence and is now re-consulting on Channel 4's MoE quota, proposing that, from 2030, in each cal- endar year at least 12% of the hours of pro- grammes made in the UK for viewing on the Chan- nel 4 service, i.e. its main channel, must be pro- duced outside England, and at least 12% of the ex- penditure on programmes made in the UK for viewing on the service must be allocated to the production of programmes outside England and using production centres in Scotland, Wales and Northern Ireland.
	As an Advisory Committee for England, under- standably we would be concerned if the proposed 12% MoE quota (a 3% increase to the existing 9%

quota) were to have a negative impact on the production sector in the English regions. We would therefore welcome reassurance that this will not be the case. In particular, in a context where our soundings suggest that amongst some indies in the English regions, because there appears to be an erosion of trust and concern about Channel 4's commissioning strategy and commitment to local indies. We also recognise that the new Channel 4 licence will run for a period of 10 years and the broadcaster's production strategy, leadership and direction could change over time, e.g. its voluntary 50% Made out of London (MoL) spend commitment.

In relation to MoE quotas, giving Channel 4 a fiveyear adjustment period and to take effect from 2030, we feel that mechanisms will be required to allow Ofcom to 'police'/ enforce them and that ongoing monitoring of progress would be beneficial, not just to ensure delivery of quotas but also to flag any unforeseen consequences, i.e. a negative impact on production in the English regions. We also believe that this could provide some assurance to indies in the English regions. Perhaps the best way to achieve this would be by publishing the percentage of commissions in England outside of London, alongside the levels for Scotland, Wales and Northern Ireland, on an annual basis as well as breaking it down further by location, e.g. Yorkshire, the Midlands etc.

We recognise that the existing annual Channel 4 Statement of Media Content Policy may be the reporting and monitoring process to do that. In addition, Ofcom will be publishing a statement to conclude on the duration and conditions of the renewed Channel 4 licence in the autumn. That statement could also give assurances to indies in the English regions, giving prominence to explaining the relationship between MoL and MoE, how Channel 4's spend will be monitored and to any enforcement powers at Ofcom's disposal.
