We feel that priority should be given to those in the market place who are currently radio owners. In the past we feel when FM licenses have come available there appears to be a lack of due diligence on the ability and deliverability of the individuals who stand behind these licence applications. The most recent example in Scotland being Ofcom's decision to award the West Central Scotland licence to what we and many others considered to be the weakest applicant with

	the least experience of operating a commercial station and the knowledge to launch or sustain it. This was then sold on to the highest bidder who is not delivering a true local service.

Please explain the reasons for your view.	Yes. These are community based services to provide something unique to that area so we feel that they must be based in the local broadcast area.
