**Question 1: Do you consider that our proposed fee rates for licences in the aeronautical VHF frequencies are appropriate?:**

No. Aeronautical use of the spectrum is to make flying safer. For years the CAA has been encouraging the use of radio in its various forms for navigation and aircraft separation to promote safety. The Ofcom proposals will have an immediate detrimental affect on flying safety.

The responsibility for flying safety should be left wholly with the CAA. Ofcom has no expertise in this issue.

The Aeronautical spectrum is governed by international agreement and so the proposals will not allow the spectrum to be used for other activities.
