Question 1:To what extent do you consider that DTT, DSat, cable and IPTV are in competition with one another for subscribers of pay TV services? either at present or in the future?:

DTT has the potential of being the biggest winner as after switchover it will be in pretty much everybody's home. The service the competition will weaken is most likely to be that of the weakest technology or lack of wide apeal. Top Up TV may suffer as they are not widely publicised - would not sky be better to help them develop their platform?

Question 2:To what extent do you consider the Proposal is likely to deliver benefits to the consumer?:

It may well be similar to the case of the old Betamax v VHS scenario. However, I would recommend at this early stage ofcom need to encourage a consistant technology across all pay services on dtt, but also the best one. It sounds to me that sky's proposal may well be a better technology that that of top-up tv. Ofcom need to decide which technology is most benneficial to the platform and perhaps encourage all services to use the same!

Question 3:To what extent do you consider that there is scope for sustainable competition in pay TV on the DTT platform and, more broadly, across all pay TV platforms?:

There is noreason if sky's dtt pay service & the existing top up tv services used the same decoding & mpeg formats that each other's box could subscribe to both services, is there? That would produce a healthy competition without the confusion of customers having to upgrade to a different box everytime.
