Question 1:To what extent do you consider that DTT, DSat, cable and IPTV are in competition with one another for subscribers of pay TV services ? either at present or in the future?:

I do not consider dtt to be in competition for subscription services, topup tv is not any real competition for dsat (sky) cable (virgin) iptv (bt/tiscali/orange) If the customer requires subscription services there are many choices available not least dsat with over 90% coverage. Terrestrial tv should be as it has in the past free for the masses that have no desire to subscribe. This proposal is nothing more that a attempt to reduce the choice of the non subscribing public, its purely a spoiling tactic to weaken freesat much the same as the buying of itv shares to stop others from doing so (also being investigated)

No i do not consider any conditions will tame bskyb, just look at the state of dsat & the amount of complaints & investigations not to mention legal cases that are outstanding against bskyb, abuse of granting epg positions, closing the epg to new broadcasters, itv shares issue, overcharging other platforms for their content.

Additional comments:

I truly believe that ddt should be for freeview with psbs getting first choice on available bandwith. purely commercial companies cannot be trusted to have the publics interest above their own , a fine example of this is the fact that no new transmitters will get the full choice of freeview channels because the commercial channels will not fund it due to the returns not being enough, this means large parts of the country will have to put up with half a freeview service or cough up for a new aerial pointing at a distant main transmitter (& even this is not allways possible to do) please do not reduce the choice further.
