Question 1:To what extent do you consider that DTT, DSat, cable and IPTV are in competition with one another for subscribers of pay TV services ? either at present or in the future?:

As all platforms have different amounts of softwares and space for channels. No real fair competition can be until all are at the size.

DTT is the poor side of digital.

It has been held back with the owners/offcom not giving it more power by its transmitters, so not all can pick up all six Mux's. Also there is no room to give a fully amount of channels like Dsat and cable. Also BskyB held it back in the past with not allowing it's channels in contacts to be put on Ondigital / ITVdigital, also sky spend big amounts at the time on adverts, DTT could not match that costs.
