Question 1:To what extent do you consider that DTT, DSat, cable and IPTV are in competition with one another for subscribers of pay TV services? either at present or in the future?:

I only feel that DSAT, Cable and IPTV are and should be in competition, I see DTT as a seperate platform neutrel service.

SKY are already the dominant playing in British TV and I don't see why they should be allowed to become more dominant. I am a SKY customer and I think they offer a fantastic product, in fact by far the best product and services available in the UK but I feel they can not offer the same service or quality on 3 channels on DTT and that these channels will become like taster or barker channels for SKY's main service and also serve to undermine the FREEVIEW DTT Platform.
