Question 1:To what extent do you consider that DTT, DSat, cable and IPTV are in competition with one another for subscribers of pay TV services? either at present or in the future?:

I consider DSat and Cable in competition with one another, however that of DTT vs DSat, they are to me seperate. With the current situation, DTT (Freeview) should remain as it is, having one provider already using up space for pay services is quite enough.

Question 2:To what extent do you consider the Proposal is likely to deliver benefits to the consumer?:

I agree it will deliver a rival service to the current pay tv service, however the removal of the free services from the DTT platform to accommodate this will reduce choice to the freeview audience.

Question 3:To what extent do you consider that there is scope for sustainable competition in pay TV on the DTT platform and, more broadly, across all pay TV platforms?:

I don't consider there to be a need for a rival pay TV service on DTT, one service is already enough, people will make the choice between the free service and other pay services themselves, offering another Pay TV alternative thorugh their aerial won't make much difference. The main requirement for a rival service is when there is abundent capacity to do so without reducing further any services currently in place.

Question 4: What are likely to be the key aspects of competition between providers of retail pay TV services on the DTT platform? E.g. what is the role of premium sports and movies content?:

I think there is a place for premium sports and premium movies on DTT. However as described before, I do not think these services should be allowed to come in place of any current free services on the DTT platform. They should be treated as extras.

Question 5:Do you consider that if Sky were to become the only provider of pay TV on the DTT platform it would be likely to have a significant detrimental effect on competition in the long term? How might this affect the development of other platforms for the delivery of pay TV services?:

Sky already monopolise (in my honest opinion) DSat, allowing them to monopolise DTT too would be a huge mistake. Sky need more competition, they need a rival on the DSat format first, not just a competitor they can easily 'bully' like on other platforms.
