# Question 1:To what extent do you consider that DTT, DSat, cable and IPTV are in competition with one another for subscribers of pay TV services ? either at present or in the future?:

I see DSat and Cable as true competition with each other for those who want unlimited channels and are not concerned as much with cost.

#### **Additional comments:**

I will miss Sky News if Sky decide to leave DTT, but that is up them, they will also lose audience figures, but their demands for pay services MUST not be given into with DTT space is too limited as it is.

People have been pleased to see the back of Game Channels, they would like to see Shopping Channels cut to two, no increase in Children's TV it is well covered.

If Sky do leave DTT perhaps a national world wide news provider like CNN may show interest that would be good for alternative opinion and coverage.

This is such an important decison for OFCOM and it must not be taken lightly - Many who will use DTT have limited budgets the retired, sick and low salary, it will be wrong to allow and dicate intridcution of pay channels, as I have said if they are not happy, then give up their channel space!
