Question 1:To what extent do you consider that DTT, DSat, cable and IPTV are in competition with one another for subscribers of pay TV services? either at present or in the future?:

Currently Top Up TV/Setanta provide the only pay TV services. Both services are compatible and are accessible via most integrated TVs, or a single STB with a slot. Most people know if they require more subscription channels then Dsat or Cable is the way to obtain them

Question 2:To what extent do you consider the Proposal is likely to deliver benefits to the consumer?:

Confusion will rein, to receive the SKY proposal another STB is required, this will cause confusion for the majority of people who have been advised by adverts that getting a STB or an intergrated TV they can receive all the channels on DTT

Question 3:To what extent do you consider that there is scope for sustainable competition in pay TV on the DTT platform and, more broadly, across all pay TV platforms?:

There is scope for increased competition as long as all encryption systems use the same technology. If you require one STB for one service and another of an alternate service, then only the most popular service will survive and it will stiffly competition.

With the limited bandwidth on DTT subscription services should be restricted. The role of premium content is very limited. Most people that require this premium content already know that they need to obtain either Cable or Dsat

Yes, there should not be a monopoly on pay TV on DTT

Yes, after having lots of channels available on Freeview the public will be concerned that in the future they will have less channels available unless they pay subscriptions. The majority of people currently use Freeview as they do not want to pay for subscription TV

Yes it is possible, SKY should provide other providers with access for £0.00 cost to other providers, i.e make no profit on adding other 3rd party providers to the system. This would also include a £0.00 admin fee for adding other providers to the system. It should also have no be a condition that even rival providers of Movies or Sport can use the system even if it is a direct rival to a service that SKY provides
