I believe that DTT should not be set aside for pay tv.

Question 2:To what extent do you consider the Proposal is likely to deliver benefits to the consumer?:

It doesn't. It only benefits Sky. DTT should be kept with its limited bandwidth for standard definition freeview services.

There is simply not enough bandwidth on DTT to waste it on subscription tv.
