I don't think it will. yes in the short term it will bring increased premium content to dtt but at what cost. With skys power/money it is enevitable(if they are allowed to use their chosen model) that in the medium to long term they will kill off all other pay tv competitors on the platform and that is not good for the consumer.

There is room for competition on dtt but it needs to be on a level playing field. All pay tv providers need to be made to offer their services wholesale to their competitors thus encouraging competition. Allowing sky to launch their own closed system on mpeg 4 and using their own encryption is not only confusing for the consumer but anti competative. There is certainly scope for competition across platforms.
