Question 1:To what extent do you consider that DTT, DSat, cable and IPTV are in competition with one another for subscribers of pay TV services? either at present or in the future?:

I believe with the introduction of new nationwide IPTV services by Orange & Tiscalli that competition between DTT, DSat, Cable & IPTV will increase significantly over

the next 5 years.

Question 2:To what extent do you consider the Proposal is likely to deliver benefits to the consumer?:

This proposal will benefit people living in areas not served by cable / satellite - i.e. tower blocks, conservation areas. The possible monopoly of future IPTV services in these areas will also be broken.

Question 3:To what extent do you consider that there is scope for sustainable competition in pay TV on the DTT platform and, more broadly, across all pay TV platforms?:

As stated above I believe competition will only increase in the future across all platforms & having more than one pay tv system available on DTT can only benefit this.

A system similar to DSat where conditional access is open to 3rd parties (& costs possible set at market value by Ofcom) would stop this becoming a issue.

I do not believe that the concerns in section 4 (mainly considering technical details, including compression & encryption standards) will concern the public as a whole or be detremental to the development of freeview.
