Question 2:To what extent do you consider the Proposal is likely to deliver benefits to the consumer?:

100% competition one to another.

Question 3:To what extent do you consider that there is scope for sustainable competition in pay TV on the DTT platform and, more broadly, across all pay TV platforms?:

Sky's objective in all this is to squash all effective competition. That said there is some scope for sustainable competition. Setanta have shown that both on Sky and DTT with their subscription sports channels. Top up Tv to a much lesser extent.

Question 4: What are likely to be the key aspects of competition between providers of retail pay TV services on the DTT platform? E.g. what is the role of premium sports and movies content?:

The key aspect/purpose is to remove available bandwidth and to thus make DTT/Freeview a less attractive proposition. As a secondary consideration for those that do subscribe Sky will be hoping to convert subscribers to their full satellite offer. Pay TV on DTT can be likened to a Trojan Horse or to mix metaphors, like a sprat to catch a makerel!

Question 5:Do you consider that if Sky were to become the only provider of pay TV on the DTT platform it would be likely to have a significant detrimental effect on competition in the long term? How might this affect the development of other platforms for the delivery of pay TV services?:

Monopoly providers by definition operate against public interest in any given field of activity. And Sky in particular has consistently shown itself to be anything but altruistic in its dealings with would be competitors.
