Yes, for the the reasons stated in respect of 6.1 above.

We reluctantly agree that such approach may be the most proportionate available in the circumstances.

We agree that this is likely to be the most proportionate measure but do not believe that it would be the most effective.

Yes, subject to Ofcom being able to conduct the subsequent auction before the end of 2008 as to delay beyond this date would likely halt the development of the market.
