




Business Radio – Simplification, Trading, Liberalisation and pricing proposals





BR Area Defined Licence Design




•Fee adjustment to reflect spectrum use (minimum licence fee will apply)

*IR 2044 to be updated to include 6.25 kHz (reference to ETSI standard) and IR 2008 Will be a 3 months public consultation through the EC



BR Technically Assigned Licence Design




*IR 2044 to be updated to include 6.25 kHz (reference to ETSI standard) and IR 2008 Will be a 3 months public consultation through the EC



Technically Assigned (MASTS)

- Two main types of assignment: **Shared** (typically up to 50%) / **Exclusive** (100%)
- Makes assignments taking into account topography, propagation model, type of assignment, antenna characteristics (inc. downtilt, downfire).....
- All assignments must conform to IR2044 (based on ETSI transmission mask)




3 Available options without Ofcom consent

- As long as type of use is not changed (i.e. shared to exclusive)
 - Change of Business Use (e.g. taxi to courier)
 - Increase/Decrease number of mobiles




BR Area Defined and Technically Assigned trading and liberalisation measures





Main issues raised by respondents

- Length of consultation
- Proposals too complex and required clarification;
- Proposals will penalise spectrum efficient usage (Trunked systems);
- Minimum trading unit of 50 Km square grid is not flexible enough;
- Complex issues where country boundary and 50km squares overlap for trading. (e.g., Cardiff/Bristol);
- No spectrum availability for area defined licence;
- Security issues regarding publication of licence information in the register;
- Enforcement and interference management;
- High fee increases, request for phased or capped fee increases;
- Continuation of charity discount;
- Stakeholder involvement/consultation on the development of TFAC (Technically Frequency Assignment Criteria) and IR (Interface Requirement);
- DMR 446 issue regarding overlapping frequency rasters (6.25 and 12.5 kHz) this is in relation to the licence exemption consultation;
- Few other comments not related to the proposals.

Summary of next steps and deliverables

- Stakeholders workshop (today, next week) To discus, clarify and respond to the main issues raised to the consultation process;
- Ofcom will issue a statement Conclusion on proposals consulted on;
- Ofcom will update the current trading and liberalisation guidance notes to reflect the extended measures;
- Ofcom will publish and work with stakeholders to develop guidance for the business radio sector on the level and extent of flexibility (trading/liberalisation) available to each new licence class;
- Ofcom will work with stakeholders and BRIG to develop the IR, TFACs, code of practice and any other documents to support the business radio spectrum reform;
- Ofcom will communicate the timescale and the process of implementing the BRR;
- Consultation on draft regulations (Fee, trading and register) before publishing the final regulations to enable the changes.
