1. Overview

The purpose of this form

A digital sound programme service intended for broadcast by means of a local or small-scale radio multiplex service requires either a C-DSP licence or a local DSP licence. Ofcom’s published guidance notes set out some of the key issues that potential applicants need to consider in deciding which type of licence is suitable for them. In summary, C-DSP services are not run for financial gain and are required to provide social gain. C-DSP licences therefore include strict conditions to ensure that happens, and provide less flexibility than a local DSP licence. However, they do provide access to capacity that small-scale radio multiplex service providers are required to reserve solely for C-DSP services.

A C-DSP licence will be required even if the same programme service is also provided on any other platforms (e.g. FM, satellite), as separate licences are required for those.

As noted above, small-scale radio multiplex services will have reserved capacity for C-DSP services. Issue of a C-DSP licence does not, however, guarantee carriage on a small-scale (or local) radio multiplex service. That is a matter for agreement between the C-DSP licensee and the multiplex service provider, and there may be more C-DSP licences issued in a locality than there are reserved slots on the small-scale radio multiplex service. Note that a C-DSP service does not necessarily have to broadcast using reserved capacity. It can use unreserved capacity on a small-scale radio multiplex service or capacity on a local radio multiplex service, again subject to agreement with the multiplex service provider.

An application for a C-DSP licence will be accepted only once Ofcom has advertised the licence for the small-scale radio multiplex service upon which the proposed C-DSP service is intended to be provided. There is no closing-date by which an application for a C-DSP licence must be submitted (i.e. it can be submitted at any time after the licence for the relevant small-scale radio multiplex licence has been advertised).

This application for a C-DSP licence by Hindu Sanskar Radio arises from the charity's decision to part ways with its current licence holder, Sabras Radio, and the need to secure an independent broadcasting platform exclusively controlled by the charity to fulfil its charitable objects. This transition will involve relocating the service to a new studio space within the Leicester broadcast area, while ensuring continuity of service for its audience. Additionally, Hindu Sanskar Radio will adopt a new web address and update its social media and other communication platforms, reflecting its commitment to maintaining and enhancing its role in the community.

Sanskar Radio has been dedicated to serving the Hindu community in Leicester and the surrounding areas (Greater Leicester Urban Area). The station promotes cultural, religious, and social enrichment among its listeners. The station’s programming is tailored to reflect and support the interests, traditions, and values of this vibrant community, providing a platform for spiritual education, cultural awareness, and community cohesion. By broadcasting in both English and key community languages, such as Hindi, Punjabi, Gujarati and Swahili, Hindu Sanskar Radio is committed to ensuring accessibility and inclusivity, fostering a shared sense of identity and pride among listeners across generations.

Hindu Sanskar Radio is deeply rooted in the rich cultural and religious traditions of the Leicester Hindu community. This community values spiritual growth, cultural continuity, and a strong sense of social identity. There is an enduring need for non-commercial services that authentically represent the community’s religious and cultural heritage, supporting all members of the community in preserving and celebrating their identity. Hindu Sanskar Radio will provide a vital platform for religious, cultural, and social expression, fostering a sense of belonging and pride. Through carefully curated programming that speaks directly to the unique character and needs of this community, the station strengthens ties across generations and promotes cultural understanding and unity.

Hindu Sanskar Radio’s charitable objects are “TO PROMOTE FOR THE BENEFIT OF THE INHABITANTS OF LEICESTER AND THE SURROUNDING AREAS THE PROVISION OF A COMMUNITY RADIO AS A RECREATIONAL FACILITY FOR THE PUBLIC AT LARGE IN THE INTERESTS OF SOCIAL WELFARE AND WITH THE OBJECT OF IMPROVING THE CONDITIONS OF LIFE OF THE SAID INHABITANTS.” Hindu Sanskar Radio is committed to fostering greater understanding within the Hindu community and its role in Leicester’s diverse social fabric. The charity focuses on delivering content that offers significant social gain. This includes on-air programming tailored to the community’s cultural and religious identity, alongside training initiatives and opportunities for community voluntary involvement in content creation, service

development, and governance. This approach not only enhances community cohesion, but also empowers the Hindu community's voice within the city's multicultural landscape.

Leicester Digital Partnership CIC, who operate the Leicester SSDAB multiplex, have agreed to offer a 100% discount on the carriage fees for Hindu Sanskar Radio. This offer is contingent upon Hindu Sanskar Radio's ongoing commitment to delivering 'significant' social gain through our programming and community initiatives.

Hindu Sanskar Radio, based in Leicester, is applying for a C-DSP licence to strengthen its commitment to providing a community radio service that upholds and promotes Hindu religious, cultural, and social values. Supported by the charity Hindu Sanskar Radio, the station will be dedicated to serving Leicester's Hindu community and surrounding areas. Our programming aims to enhance cultural awareness, social engagement, and educational enrichment, supporting listeners' understanding and appreciation of Hindu traditions, culture and outlooks.

This application supports Hindu Sanskar Radio's vision to deliver a non-commercial, community-led service that responds to the needs of its audience. The station will operate on a not-for-profit basis, with all resources reinvested to improve and expand programming that connects with its listeners, fostering a sense of belonging and cultural pride. This C-DSP licence will enable Hindu Sanskar Radio to consolidate its reach, ensuring it remains a valuable resource for Leicester's diverse and dynamic Hindu community.

Hindu Sanskar Radio will provide social gain that is tailored to the needs and interests of Leicester's Hindu community:

- 1. Community Development:** The station will foster connections across the community, promoting cohesion and engagement through broadcasts that highlight local events, social initiatives, and opportunities for involvement in community activities.
- 2. Information and Support:** Hindu Sanskar Radio will serve as a hub for community information, sharing important news, public health messages, and resources on local services that are vital to listeners' well-being.
- 3. Cultural and Social Identity Support:** The station's programming will reinforce a strong sense of cultural pride, providing content that reflects and respects Hindu

traditions, values, and social practices, thus strengthening listeners' cultural identity.

4. Discussion of Topics of Concern: By facilitating conversations on important community issues—such as youth engagement, elder support, and social integration—Hindu Sanskar Radio will give the community a voice to express concerns, explore solutions, and unite around shared goals.

5. Religious Messages: Religious programming, including prayers, sermons, and celebrations of Hindu festivals, will provide spiritual support, connecting listeners to their faith and fostering a deeper understanding of Hinduism.

6. Training and Skill Development: Hindu Sanskar Radio will offer training for community members in broadcasting, communication, and organisational skills. This includes hands-on experience in production, public speaking, and radio operation, equipping them to become effective communicators and contributors to the station's mission.

7. Involvement in Governance and Fundraising: Community members will be encouraged to participate in the management and governance of the station and its supporting charity, developing leadership skills by engaging in fundraising and outreach activities that sustain and grow the station's impact.

The trustees of Hindu Sanskar Radio have considerable experience in community broadcasting, having managed broadcast services for Leicester’s Hindu community since 2007. Familiar with Ofcom’s Broadcasting Code, a designated compliance officer will ensure adherence to content standards, fairness, and privacy regulations as defined in the Broadcast Code and other relevant regulations.

The station is part of a network of local community broadcasters in Leicester who regularly share updates and offer mutual support on compliance matters. This network, along with periodic training from community media consultants, helps the team stay current on regulatory practices. This includes working with Decentered Media as a training and process development consultant.

Hindu Sanskar Radio has developed a straightforward training programme for volunteers, covering key compliance topics, including content standards and privacy guidelines. This approach ensures that Sanskar Radio’s broadcasts consistently meet regulatory standards while remaining responsive to the needs of Leicester’s Hindu community.

The trustees of Hindu Sanskar Radio have been managing a community radio service since 2007, gaining significant experience in regulatory compliance. They have attended local training and briefing sessions and participated in Ofcom-organised sessions to stay informed on best practices and regulatory updates. Additionally, the trustees engage with other community broadcasters in Leicester to strengthen their understanding and application of compliance requirements, ensuring the station operates to high standards and serves the needs of the community effectively.

- 3.3 For each role within your compliance team please provide job title and a brief description of the functions of the role specific to ensuring compliance of the proposed service. The compliance team at Hindu Sanskar Radio has clearly defined roles to ensure that the station adheres to regulatory standards and maintains high-quality programming:

Programme Manager: The Programme Manager sets and oversees Hindu Sanskar Radio's programme policy and manages the broadcast schedule. They review music and other content before it is uploaded to the database or scheduled for broadcast. Working closely with the Compliance Officer and Training Officer, the Programme Manager ensures that presenters understand and meet required standards. This role includes maintaining up-to-date knowledge of the Ofcom Broadcasting Code and ensuring the station's Key Commitments are reflected in programme content.

Compliance Officer: Reporting to the Programme Manager, the Compliance Officer monitors station output to ensure it complies with the Broadcasting Code and Sanskar Radio's policies. They schedule music and other content in alignment with station guidelines, supporting consistent and responsible programming.

Training Officer: The Training Officer, also reporting to the Programme Manager, develops and implements a training programme to ensure all staff understand station policies and regulatory requirements. This includes providing induction and ongoing training for presenters, covering essential aspects of broadcasting standards, compliance, and adherence to the Broadcasting Code. The Training Officer's role ensures that all presenters are equipped to maintain the station's standards in line with Hindu Sanskar Radio's policies.

- 3.4 How does the applicant intend to formally train staff in compliance procedures? Please include details of the compliance training that will be given to those responsible for live programming, including compliance staff, presenters and producers.

At Hindu Sanskar Radio, all volunteers undergo induction and ongoing training tailored to their roles within the organisation. Volunteers involved in on-air roles receive thorough training in studio operations, presentation, and interviewing skills, led by experienced team members. New presenters are mentored by the Training Officer, who monitors their progress and provides support as needed.

For on-air roles, training covers legal responsibilities, including a detailed overview of Ofcom's Broadcasting Code, and each presenter is provided with a copy of the Code for reference. Hindu Sanskar Radio encourages creativity in programming without strict adherence to a style guide, relying on individual discussions with experienced volunteers to help new presenters explore their own style confidently.

Training duration is flexible to accommodate volunteers' outside commitments, with most completing their initial training within three months. Station output is regularly monitored, with constructive feedback offered to help presenters develop and maintain high standards. In cases where standards may not be met, additional training or temporary removal from broadcasting may be implemented to ensure compliance.

Training at Hindu Sanskar Radio is mandatory for all new volunteers, with tailored sessions based on each role. Volunteers involved in on-air presenting are required to complete additional training to ensure a solid understanding of broadcasting standards and compliance. More experienced volunteers play a supportive role, mentoring newer members and offering guidance throughout their training period.

Before beginning their role, all volunteers sign a Volunteer Agreement, affirming their commitment to Hindu Sanskar Radio's rules and values, including adherence to the Broadcasting Code, relevant legislation, and station policies. This structured approach to training ensures that all volunteers are well-prepared to uphold the station's standards and values in their roles.

All programming on Hindu Sanskar Radio will fully comply with the Ofcom Broadcasting Code, with robust compliance processes and monitoring systems overseen by the trustees. Our experienced volunteers, who have been managing a compliant radio service since 2007, are instrumental in upholding these standards.

Only presenters who have demonstrated a thorough understanding of compliance requirements and broadcasting best practices will be permitted to broadcast live independently. The Programme Manager, in consultation with more experienced presenters, will assess each presenter's training record, experience, and readiness to handle live broadcasts. Initially, new presenters will work under the guidance of seasoned volunteers to ensure they are well-prepared.

The Programme Manager will routinely verify that presenters understand the Broadcasting Code's requirements, know how to address on-air challenges, and are prepared to manage potential compliance issues, including the actions of guests. This approach ensures a consistent and high level of compliance across all Hindu Sanskar Radio broadcasts.

All pre-recorded material broadcast on Hindu Sanskar Radio will strictly comply with Ofcom's codes and standards. Only the Programme Manager or an experienced volunteer, who has completed compliance checks, may load music and pre-recorded features into our playout system.

To ensure consistent adherence to the Broadcasting Code and station policies, only a select group of experienced presenters may use personal music collections for their shows, with their content closely monitored by the Programme Manager and Compliance Officer.

For externally produced content, such as syndicated programmes, we only accept material from reputable and trusted sources. Each programme is reviewed by the Programme Manager prior to scheduling to ensure full compliance.

All volunteers at Hindu Sanskar Radio sign a Volunteer Agreement, affirming their commitment to the station's rules and values, including compliance with the Broadcasting Code, relevant legislation, and station policies. This structured approach to content management safeguards the integrity and compliance of Hindu Sanskar Radio's broadcasts.

- b) that having made all reasonable enquiries neither the applicant nor any person controlling the applicant, as a result of the grant to me of the licence, breach any requirement of Schedule 14 to the Communications Act 2003 with regard to the accumulation of interests in broadcasting services or to the restrictions on cross-media interests; and
- c) that the applicant is not disqualified by virtue of the provisions of section 143 (5) of the Broadcasting Act 1996 in relation to political objects and the provisions of section 144 (3) of the Broadcasting Act 1996 in relation to the provision of false information or through the withholding of information with the intention of misleading Ofcom; and
- d) that no director or person concerned directly or indirectly in the management of the applicant is subject to a disqualification order as defined by section 145 (1) of the Broadcasting Act 1996.

4.3 I understand that Ofcom reserves the right to revoke the licence (if granted) if at any time any material statement made to Ofcom is found to be false and to have been by the applicant or any member or officer thereof knowing it to be false. I also understand that under sections 144 and 145 of the Broadcasting Act 1996, the provision of false information could incur a criminal conviction and a disqualification from the holding of a Broad-casting Act licence.
